

Privacy Policy

Konnexus Limited is committed to protecting the privacy of the personally-identifiable information that we collect from you as you use this Web site (the "Site"). The scope of Konnexus Limited's commitment is detailed in this Privacy Policy. By submitting information, you agree to Konnexus Limited's use of such information as described herein. Please see our Terms of Use for more information about our on-line policies in general.

What personally-identifiable information is collected?

Konnexus Limited collects personally-identifiable information ("Personal Info") on certain areas of the Site when users register, request information or a response, sign up for events and participate in user posting areas, such as bulletin boards, discussion forums, and surveys. The personally-identifiable information collected may include, without limitation, your access ID/password, company or other affiliations, and contact information (names, mailing and e-mail addresses, phone/ fax numbers).

How may my Personal Info be used?

Konnexus Limited uses your Personal Information to fulfill your requests for information, to process your requests to participate in events that you may submit. We may keep any of your Personal Info on file and use it to contact you for site related purposes. Konnexus Limited may also use Personal Info in analysing Site user behaviour in order to measure interest in specific items posted on our Site. The e-mail addresses provided at registration allow Konnexus Limited to send e-mail to individuals based on the areas of interest, if any that they indicate during the registration process. If you do not wish to receive e-mailed advance notice of items posted on the Site, simply do not check off any of the subject boxes on the registration page. Konnexus Limited uses Personal Info collected from cookies and IP addresses as described below. Konnexus Limited may provide your Personal Info to any of its affiliates worldwide for such purposes.

Google Remarketing

Konnexus Limited may use Google Remarketing campaigns to advertise to visitors while they browse other sites across the internet. Due to this visitors to the www.konnexuk.com, www.konnexusb2b.com, or other affiliated websites may encounter advertising from Konnexus Limited while they browser the web, enabled by 3rd party vendors such as Google. Third party vendors, such as Google, use cookies to track your visit to this website in order to serve relevant ads during your future browsing sessions of the internet.

Are cookies and IP addresses used?

The Site uses cookies to identify you and to track usage of the Site. Is personally-identifiable information disclosed to third parties?

1. Konnexus Limited may disclose your Personal Info to third parties as required or permitted by the laws, rules, and regulations of any nation, state, or other applicable jurisdiction;
2. Konnexus Limited may disclose your Personal Info to third parties who deliver information from us to you for the purpose of performing such delivery;
3. Konnexus Limited may disclose your Personal Info if, in connection with submitting the information, you consent to such disclosure;
4. Konnexus Limited may disclose contact information for you in response to inquiries by bona-fide rights owners in connection with allegations of infringement of copyright or other proprietary rights arising from information you have posted on the Site or otherwise provided to Konnexus Limited;
5. If Konnexus Limited and/or any of its affiliates merges with or sells substantially all of its assets or a majority of its equity to a third party, information collected by Konnexus Limited or such affiliates on their Web sites may be disclosed to and owned by the merged entity or third party.

Tran border hosting and transfer of information
